LIFE IN THE COTTAGE

What it takes to restore hope

We both have worked at Intermountain as direct care staff for around six years, and have worked together as partners in McTaggart Cottage for about four years. Often, we are asked about what we do as counselors, so we would like to share some of the work with children we are fortunate enough to

do on a day to day basis. To start off, it might be helpful to have an understanding of the children we work with.

In our cottage we have eight children, three girls and five boys, with an age range of 8-12 years. The majority of these children will be with us anywhere from 18-24 months. Often the children that are admitted to our program have experienced severe

abuse, trauma, or neglect from their caregivers in the first few years of their life. It is also likely that have had multiple placements in different homes with several different unpredictable caregivers. Due to this, these children come to us not trusting that we, or any adult, can or will take care of their physical or emotional needs. They perceive closeness to adults as threatening and intimidating and therefore, frequently engage in a variety of behaviors to distance themselves from adults. Our primary role is to provide these children with a different life experience, and show them that adults can be safe, caring, nurturing, supportive, and loving.

There are several ways we go about structuring our cottage to create and facilitate trusting and nurturing relationships with the children. Ultimately, we want to provide safety and consistency through setting up predictable structures, routines, boundaries, and limits. We want to provide teaching opportunities to these

children by helping them learn different ways of responding, and by showing them how to respect others, and most of all themselves. So many of our children believe that they

do not deserve anything good, and so we are firm believers in allowing our kids to be kids, and teaching them to play and have fun.

We try to make the cottage as family-like as we can, and have both a male and female counselor working as partners, so that the children experience relating to both father and mother figures. Through our partnership we try to model what a healthy relationship looks like for the children, and encourage them to be direct, open, and honest, and to take risks to share their feelings. Having this male and female dynamic really helps to bring balance to the cottage, by having each of us provide our unique perspectives. Often times, our children have an extreme amount of maternal anger and rage that is transferred to the maternal attachment, and having a male partner step in, helps facilitate a supportive and emotionally corrective relationship between the child and the “mom” figure. Much like any family, we pick the children up from our on-campus school, have them do homework and snack time, play outside, do chores, help us make meals, sit down together to eat, spend time providing closeness and nurture, and then get ready for bed.

We also provide opportunities for the children to share how they are feeling and find ways to support them with these feelings.

In working with these kids, we have been provided with the opportunity to see them grow and change throughout their treatment. Sometimes these changes are slow and happen after much labor and pain, but it is an amazing feeling to be a part of the change, and to be able to hold onto hope for their future.

We believe that we are planting seeds now that will one day come to harvest. Little by little, we get to see the kids taking small risks to trust us, to talk to us about their feelings, and to become more accepting of our nurture and closeness. We get to be with them as they experience and try new activities, such as backpacking, camping, or skiing for the first time, and be with them as they move through their fears and anxieties. All of this creates a close and connecting bond both for them and us. Working with these children has also helped us to experience our own growth and change. It has given us greater self-awareness and understanding about who we are, and so we feel truly blessed to work for Intermountain and be a part of these children’s lives.

GENERATIONAL HOPE

Last month, as I was making my way across the courtyard of our campus, my attention was drawn to graffiti. Thankfully, the canvas was not one of our buildings, but rather snow! Using food coloring, our kids had transformed a growing mound of bleak snow that lined our sidewalk into a colorful display. There, among the bright array of snow pictures and drawings, someone had inscribed the word “hope.” I wondered who had written this, and what had been their inspiration? Perhaps it was an especially good day at school or maybe a significant breakthrough towards a forever family. Whatever its source, it took me back to my earlier work as a cottage counselor.

Frankly, it was tough to work day after day with children who have - because of trauma, chaos and disappointing setbacks – abandoned hope for a promising future. I learned from experience that in many cases, *the despair these kids felt was something that had been passed on to them from previous generations.* The restoration of hope in their lives was a process that took an enormous amount of time, patience, and loving care. There are no shortcuts to creating a bridge of trust that allows healing. It is hard work. But it is all made worthwhile when the tide begins to turn and you realize that hope has taken root in a child’s heart.

We have made great strides in our understanding of how to heal children who have experienced significant setbacks in childhood and who carry the burden of generational pain and despair. We are succeeding in breaking the cycle. And our impact continues to grow deeper and broader. In 1998, Intermountain was serving 42 children. Today, through a host of programs, we are annually serving over 1,000 children and their families from all over Montana. We are providing valuable training and education services to parents, teachers, and child care professionals all over the state and beyond.

As I write this, there are telltale signs that the long and wet winter is beginning to relent; the days are longer and the temperatures warmer. *In the same way that the long Montana winters eventually give way to spring, so too can the generational grip of despair in a child’s life give way to hope.* You make it possible through your generous support. You are a part of changing the course of history not only for this generation, but for future generations of children as well! May you be richly blessed for what you do on behalf of our children.

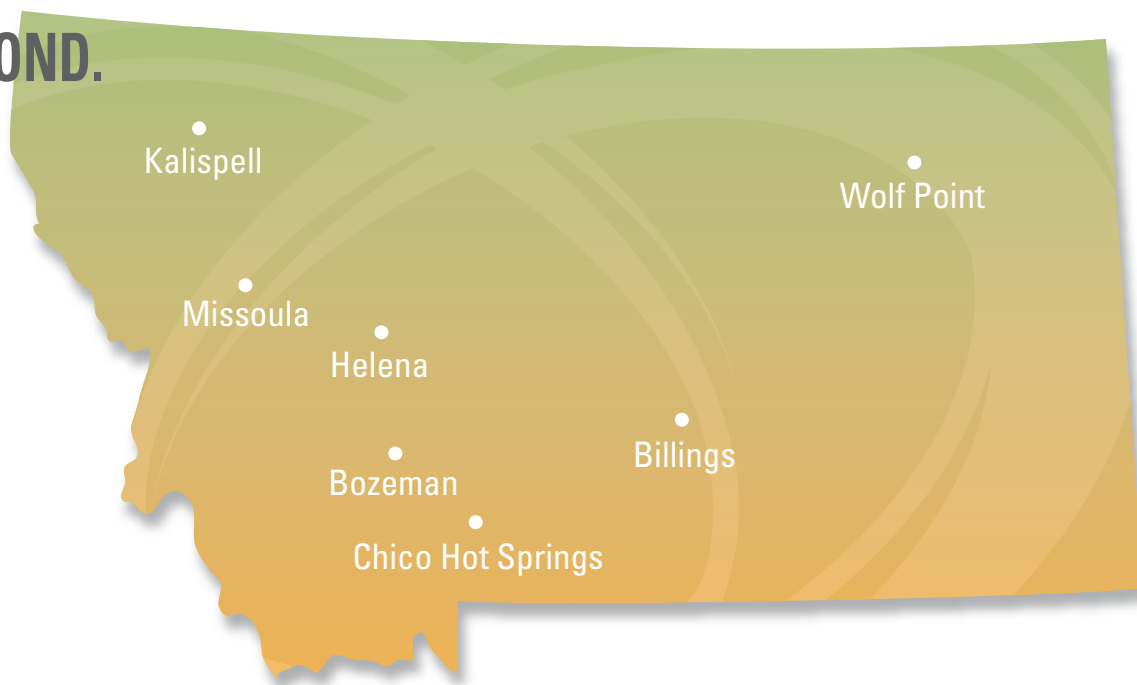

RANDOM ACTS OF KINDNESS BECOME PREDICTABLE with Intermountain President's Council

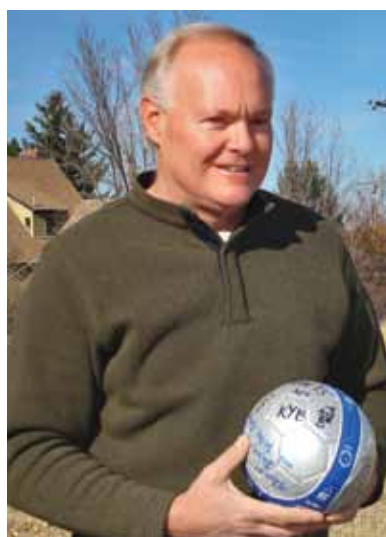

The IPC was first formed back in 2007, and is currently 53 members strong including 15 couples and 21 individuals. But financial support is only a small part of the IPC story. The really amazing thing is the gift of the one personal resource that is guaranteed to diminish every day for every one of us—the gift of time. That's where the generosity of our Council members really shines.

PARTRIDGE BUILDING: A Springboard

You have no idea how a building can springboard an organization towards its potential! A case in point is our facility for community based services.

Intermountain received a \$300,000 challenge grant from the Montana Mental Health Settlement Trust. We were one of eight to receive first-round funding out of nearly 300 applications because of its importance for Montana’s youth. The challenge grant of \$300,000 is designated for a community services facility.



Intermountain recently received a grant to purchase this building for community services in Helena.

Community Services provide therapeutic support to all school grade levels in the Helena and East Helena School Districts. Education resources include parent support, individual and family therapy, individualized treatment planning, emotional and behavioral

support, crisis intervention, and non-school day activities. Other outpatient services include psychiatry, psychological assessment, therapy, day treatment, therapeutic foster care, adoption licensing, and family-based services.

is to consolidate community services into one Helena location to allow for their optimal integration on behalf of the client. Currently, outpatient services provide care for over 500 youth in the greater Helena area.

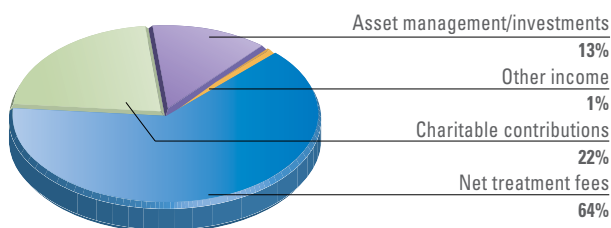

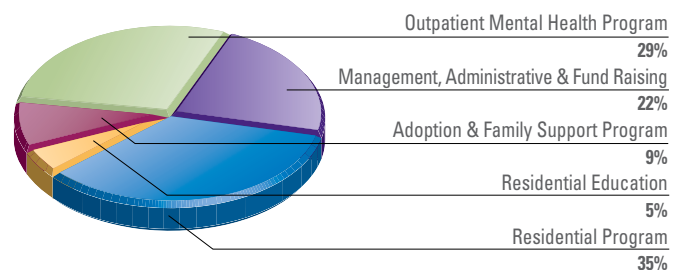
