In November of 2022 the organizations Chief Financial officer unexpectedly resigned causing disruption and instability within the Financial operations of the organization. The organization took action recruiting for CFO roles. In 2023 the organization entered in to an agreement with an organization to provide CFO services, however In 2023 the organization experienced additional disruption that was the result of the termination of the contract with the organization that was to provide CFO services within the organization.
